

## **Eel River Bar-Indigenous Community Business Fund (ICBF)**

On June 11, 2020, the Honourable Marc Miller, Minister of Indigenous Services, announced funding for community-owned First Nation, Inuit and Métis businesses, including micro-businesses, who are not eligible for existing business support measures. Eel River Bar is pleased to announce they are participating in the Indigenous Community Business Fund (ICBF). This fund will help Eel River Bar businesses to mitigate the financial pressure experienced and allow for our community-owned businesses and micro-businesses to strengthen operations and increase business viability during the pandemic, with the goal of positioning our businesses for recovery.

Business must be owned by an Eel River Bar Band Member

Business must have been in operation prior to the COVID-19 pandemic (March 2020)

Must be able to demonstrate your business has lost or is losing revenue during the COVID-19 pandemic

Must not have received funding from Federal COVID-19 programs (BCAP, CEBA, CEWS, CECRA, RRRF, LEEEF or other support targeted at Indigenous Businesses)
