CHIEF'S UPDATE

- Land's manager brought forward a past BCR to give a member the CP for their property, though CP's are on hold right now C&C thought it prudent to honour the BCR that had been signed before the hold was placed on issuing Certificates of Possession

- Land dispute between community members was reviewed, decision was that this is a civil matter
- Off reservation property offered for sale, will need an independent assessment of the land
- Purchase of La Source was discussed, the band will loan monies to the Ec/Dev Corporation to purchase, Ec/Dev will pay monies back to the band
- Lands committee to be included in meetings for land purchase
- DFO meeting with Marc Godin and Luc Legere, council wants to support our fall fisheries, will address miscommunication from the DFO officers, will discuss moderate livelihood in place of Food, Social and Ceremony

- Discussion on potential contract for Training, Chief will discuss with H/R
- Discussion on Internal Promotion for Sports & Rec Coordinator, will create a job description for the Coordinator, as well as a Director of Sports & Rec to be posted
- Forestry was tabled
- Heron Bay Water Line on Dam Rd. will meet with the Mayor, Boissoneault McGraw, on August 24th.
- BCR for Own Source Revenue and non members was signed
- BCR for removal of non member Colson Dedam was signed
- Discussion of issuing a PSA for resignation of councillor
- Labour Day Community Event Donation Request was approved, a MIC by Councillor D LaBillois Bjorndal to donate \$500.00, 2nd by Councillor Karen Narvie, vote 5/0 Aye... motion passed
- Marauders Sponsorship for \$5,000. was approved Motion in Council by Councillor D LaBillois Bjorndal 2nd by Councillor Tiffany Boyd, vote 5/0... Motion Passed
